

**Bill Jones 2008 Cozumel Trip  
Liability Release and Assumption of Risk Agreement**

Read carefully and fill in all blanks before signing.

I, \_\_\_\_\_, hereby affirm that I am voluntarily engaging in travel, transportation, food, drink, hotel accommodations, water sports, and all activities on my trip to Cozumel Mexico on July 28, 2007. In consideration of my being allowed to participate in this trip, I hereby personally assume all risks of this trip. These activities may include but are not limited to Scuba Diving, Scuba instruction and training, snorkeling, boating, and all other activities that I engage in during the trip. I am aware that Skin Diving, Scuba Diving, and Scuba Training have inherent risks, which may result in serious injury or death and I am fully aware of and expressly assume all risks known and unknown for all activities for the entire Cozumel Trip. If I engage in Scuba Diving, I affirm that I am a certified diver with a greater than or equivalent to "PADI Open Water Diver" certification. I understand that I may be diving at a site that is remote by either time or distance or both from a recompression chamber and other medical treatment that may be required for my proper medical care.

I understand and agree that Bill Jones may not be held liable or responsible in any way for any injury, death, or damages to me, my family, estate, heirs, or other assigns that may occur as a result of my participation of any activity associated with this Cozumel Trip or as a result of the negligence or actions or inactions of Bill Jones whether passive or active.

I further state by this "Agreement" to exempt, release, indemnify, and forever defend and hold harmless Bill Jones and his heirs from all liability and responsibility for personal injury, wrongful death, property damage, travel segment loss, travel expenses, ticket costs, lost wages, and any loss of any kind, however caused, including but not limited to product liability or the actions or inactions of Bill Jones whether passive or active in connection with this Cozumel Trip.

I further state that I am of lawful age and legally competent to sign this Liability Release and Assumption of Risk Agreement or that I have obtained the written consent of my parent or guardian. I understand the terms herein are contractual and not a mere recital and that I have signed this "Agreement" of my own free act and with the knowledge that I hereby agree to waive my legal rights. I further agree that if any provision of this agreement is found to be unenforceable or invalid that only that provision shall be severed from this "Agreement" with the remainder of this "Agreement" construed as though the unenforceable provision had never been contained herein.

I further affirm that I have read, understand, and agree to the package conditions (stated in the "Bill Jones 2008 How to buy tickets" handout) including but not limited to the conditions that the Ticket / Voucher is Non-Transferable & Non-Refundable & has no cash value and that Divers Must Show Proof of Certification & Experience. I understand that failure to show up on-time for transportation on any leg of the trip will result in your non-refundable loss of that portion of the travel package. I understand that I will be required to carry a current passport that has at least four blank visa pages and will not expire within six months of the travel dates.

I have fully informed my heirs and myself of the contents of this "Agreement" by reading it before signing it on behalf of my heirs and myself.
